SCHEDULE 2

Conditions

1. Only changes to the Civil Aviation Act 1988, the Civil Aviation Safety Regulations 1998, the International Civil Aviation Organization- Technical Instructions for the Safe Transport of Dangerous Goods by Air, and the International Air Transport Association- Dangerous Goods Regulations, in force from time to time, may be reflected in the training course material without CASA approval.
 2. A person may only undertake the training course listed as Item (b) in Schedule 1 if, within the two year period, as defined in CASR 92.090, immediately preceding their attendance at this course, they have undertaken a training course approved for Group A employees covering all classes of dangerous goods.
 3. A person may only undertake the training course listed as Item (g) in Schedule 1 if, within the two year period, as defined in CASR 92.090, immediately preceding their attendance at this course, they have undertaken a training course approved for Group F employees covering all classes of dangerous goods.
 4. The courses listed as Items (c), (d),(e) and (h) in Schedule 1, may be delivered by distance education methods being by correspondence or web based training.
 5. Persons completing the course listed as Item (h) in Schedule 1 are limited in their duties to only those dangerous goods of the class, hazard division or UN number listed. This limitation must be clearly reflected in the in all course documentation and any certificate issued or course record maintained.
 6. This approval is subject to a satisfactory standard of course being maintained.
 7. The Civil Aviation Safety Authority may revoke this approval if it is necessary in the interests of the safety of air navigation.

Exclusion from Dangerous Goods Training – all persons

1 Application

This instrument applies to all persons who successfully completed a Dangerous Goods Training Course between 14 November 2010 and 31 December 2010 conducted by the DG & Safety Pty Ltd and previously approved under CASA Instrument MLDG 137_07.

2 Exclusion

Any person who has successfully completed a Dangerous Goods Training Course between 14 November 2010 and 31 December 2010 conducted by the DG & Safety Pty Ltd and previously approved under CASA Instrument MLDG 137_07 is excluded from the obligation to comply with Civil Aviation Safety Regulations 92.095, 92.100, 92.105 and 92.120 subject to the Conditions of this Instrument.

3 Conditions

- a) This exclusion shall only exclude a person from dangerous goods training relevant to the employee group and Civil Aviation Safety Regulation applicable to the dangerous goods training course they completed with DG & Safety Pty Ltd.
- b) The validity period for the dangerous goods training course completed by the persons applies as though the course previously approved under CASA Instrument MLDG 137_07 was approved at the time the persons completed the course.
- b) CASA may revoke this exclusion if it is necessary in the interests of the safety of air navigation.
